THE FOLLOWING DOCUMENTS MUST BE PROVIDED WITH THIS APPLICATION TO THE SECAUCUS MUA located at 1100 Koelle Boulevard, Secaucus, NJ 07094:

- 1) Copies of governmental planning approvals or certification stating that no approvals are necessary. SMUA approval cannot be granted without such certification.
- 2) NJDEP Treatment Works Approval Application (if required).
- 3) NJDEP/WQM-006 Engineers Report (if required).
- 4) Site Plans including Architectural, plumbing and building connection to the sanitary system.
- 5) Residential applications for 900 gallons per day or less: No charge. Residential sewer connection application in excess of 901 gallons per day: \$0.25 per gallon not to exceed \$5,000.00. Non-residential sewer connection application: \$500.00 per connection plus \$0.25 per gallon for each gallon over 2,000 gallons. Not to exceed \$5,000.00. A check in the appropriate amount should be made payable to the "Secaucus MUA".
- 6) For any replacement of existing connection or new construction, the sewer line must be brought out to the main line in the street.
- 7) The Authority must be notified at least 24 hours prior to the connection being made for inspection. A final CO will not be issued unless an inspection is completed.
- 8) If the applicant chooses to use a payment plan, one-half of the fee must be paid prior to the issuance of any construction permits. The second half is due and payable prior to the issuance of a C.O. and will be assessed at the rate of the connection being made. This application is valid for a period of two years from date issued.
