## **RESOLUTION 2016-04-04B**

AUTHORIZING THE PURCHASE OF ONE (1) EVO-SP-2600G SYSTEM COMPLETE WITH GAS TRAIN ASSEMBLY MANUFACTURED BY ENER-G RUDOX FOR ITS USE IN ITS EMERGENCY GENERATOR DUAL FUEL UPGRADE PROJECT. **WHEREAS,** the SECAUCUS MUNICIPAL UTILITIES AUTHORITY (hereinafter "Authority") is a public body, duly formed under the Municipal and County Utilities Authority Law, constituting Chapter 183 of the Laws of 1957, as amended (Chapter 14B of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

**WHEREAS,** the Authority has the need for a dual gas generator conversion kit at its Wastewater Treatment Plant (WWTP) which will be used in its Emergency Generator Dual Fuel upgrade project (the "Project"); and

**WHEREAS,** the Authority needs to specify converter equipment for this system that has a proven track record, low maintenance, and compatible with the Authority's existing Mitsubishi Generator; and

**WHEREAS,** the system as manufactured by ENER-G Rudox is the sole dual energy conversion kit approved for use on Mitsubishi Generators; and

**WHEREAS,** the Authority has determined that the EVO-SP-2600g System complete with gas train assembly is necessary for the conduct of its affairs; and

**WHEREAS,** the Authority therefore has a compelling need to specify this equipment as authorized by <u>N.J.S.A.</u> 40A:11-13 and <u>N.J.A.C.</u> 5:34-2.2 where the sole source designation overshadow the benefit of use of "brand name or equivalent"; and

**WHEREAS**, the Authority's Attorney has reviewed the proposed certification for the special need for the sole source equipment and has reviewed the proposed certification for the special need for the sole source equipment and has advised of its applicability and acceptability pursuant to <u>N.J.S.A.</u> 40A:11-13 and <u>N.J.A.C.</u> 5:34-2.2.

NOW, **THEREFORE**, **BE IT RESOLVED** that Members of the Secaucus Municipal Utilities Authority:

That the Authority agrees that due to the specialized nature of this equipment necessary for the conduct of its affairs, the only acceptable manufacturer for the equipment installed as part of the Emergency Generator Dual Fuel project is the EVO-SP-2600g System complete with gas train assembly manufactured by ENER-G Rudox.
- 2. This Resolution for sole source equipment shall be made part of the bid documents.

### Report of the Executive Director March 2016

• Continued sampling the membrane filter pilot system currently being tested at the NBMUA Woodcliff Treatment Facility. We will have analytical data for the possible removal of copper in the waste stream. Copper is a metal that our facility is pending a limit that cannot be met through the traditional treatment methods at the Koelle Boulevard Facility.

- PSE&G has installed the high pressure gas line. Waiting on contract specifications to go out to bid for the purchase and installation of the dual fuel converter {on Agenda for this meeting}.
- The Authority's Environmental/Regulatory Engineering firm PS&S has been assisting with the documentation/submittals for the grant(s) funding.
- Awaiting a report from Gabel Associates regarding the possibility of another array of solar panels that would be marketed through a third party contractor at no cost to the Authority.
- Continued researching the possibility of lining some of the manholes in the collection system that may be in need of repair. There are several firms that market the equipment for this type of repair but not many firms want to come out and demonstrate a product.
- Continued contact with the Town regarding the possible connection of the USCG Auxiliary building to the SMUA sanitary on Meadowland Parkway.
- One of the yard hydrants line broke. While repairing this, it was discovered that there were numerous conduit feeds that were improperly installed. We will have to excavate to determine the scope of work.
- Received preliminary report on SCADA feasibility study and met with ENSOCORP to discuss. Chuck Cuyulis will give a brief presentation at the April meeting.
- For the month of March 2016, the Jet Truck was out eleven (11) full days assisting the DPW.

### SECAUCUS MUNICIPAL UTILITIES AUTHORITY ENGINEERS REPORT FOR THE MONTH OF MARCH 2016

The following is a list of the main activities as provided by this office to the Authority for the above-mentioned month:

Toscana - Discharge violations have occurred on June 3, 2015, July 13, 2015, July 23, 2015 and August 6, 2015. On September 14, 2015 a discharge occurred at the Toscana facility. Authority Attorney and the Toscana Attorney are working on a settlement. A discharge occurred on September 29, 2015 having an acidic pH of 4.32. A discharge has occurred on November 24, 2015. A discharge has occurred due to a rupture line on December 20, 2015. To be removed from monthly report unless future discharges occur or information is needed to transfer. Toscana has installed a vertical vessel for storage of their product waste for sale.

Started design and specifications for the Generator conversion to N.G. I am still waiting on information from the manufacturer on the required installation requirements. PSEG will extend a high pressure line form Huber Street. Through value engineering, we revised the route of the PSEG gas line, new cost to PSEG has reduced from \$94,966.74 to \$75,720.04. Meeting with the manufacturer concerning design aspects of project, revising drawings according. SMUA sent PSEG check for high pressure line extension. PSEG to start gas line extension when recent snow is removed. High pressure line has been installed. Will seek a resolution to allow a sole source bidding process for the gas/diesel convertor. Specifications and Plans are being finalized for Bids in April 2016.

Still looking into a design to supply sanitary services to the Coast Guard Building. Designed a gravity system from the property line to a manhole on the trunk sanitary sewer in Meadowlands

Parkway, waiting on an estimate from the contractor. Received an estimate for the gravity line, will look at a pump station with gravity line. Waiting on the estimate for the force main and pump station. Received information on the pump station, however, it has been revealed by the Town electrician that sufficient power is not available for a pump station and a new 3 phase service would need to be installed. Received quote for installation of a force main. Complying the costs of the force main, pump station installation and new power source. Submitted to Town for review. We have been contacted by the Building Department and the Mayor concerning this project. The Mayor has requested a meeting on this project. Waiting on his availability.

Spoke to the applicant's engineer about a proposed connection at 1 County Avenue. Reviewing application. Engineer received review letter and stated that the design may change. Unsuccessful attempt to return calls to Applicants permit engineer. Waiting on design plans from the applicant

Contacted Tax Department to ascertain new tax maps for use by the Authority for facilities inventory. Waiting for meeting schedule. Will be attending a meeting at NJSIA on their GIA/Meri system. The tax department is waiting on a proposal from the TownE to update the Tax Maps.

Met with PSEG concerning the possible expansion of the existing Solar Panel System. Sent elevations and cross section of the Primary Clarifier tanks to Contractor. Contractor will get back to us with their findings.

Excessive grease accumulated at the Turnpike PS, investigating. Also increase flow is being experienced at the Turnpike PS.

The pump guide rails and support have been compromised at the Seaview Pump Station. Reaching out for proposals to repair. Rapid Pump submitted a proposal of \$4,290. Awarded contract to Rapid to repair. Work has started with an expected finish date of 3/31/2016

Spoke with National Watermain and others concerning a manhole lining/coating system for the collection system older brick man holes throughout the Town, especially the Clarendon Area. Also looking into the Predl rehabilitation system. Waiting on a date from a contractor to demonstrate a rehabilitation procedure.

Reviewing status of existing bucket chains and sprockets on Grit Chamber #3. Possible need to replace chains. Facility to order chains.

Started investigation to determine the capital cost for the replacement of the trickling filters plastic media.

Investigating the leaking of the plant water system by the secondary clarifier area. Also looking into a replacement for a 1-1/2" yard hydrant that has been deteriorated beyond use. Hydrant has been ordered, waiting on delivery. Additional conduit have been found that doesn't appear to be properly installed, will investigate.

Prepared the 2016 COAH report.

### OPERATIONS REPORT – February 2016 Submitted March 7, 2016

#### KOELLE BOULEVARD FACILITY

- 1) The average daily flow for the month was 3.1879 MGD. Maximum daily flow was 4.8992 M.G.; the estimated total flow for the month was 91.6142 MG.
- 2) The Odor Control system was drained and cleaned.
- 3) The monthly test was conducted on the Emergency Generator.
- 4) The recirculation pump for boiler number two was replaced. A new actuator was also installed on the heat valve.
- 5) Routine maintenance and grounds keeping were performed.
- 6) The Serpentine tank was drained and cleaned.
- 7) Plant water pump number one was repaired and is back in service. Plant water pump number two was sent out for repair, also a new Aurora plant water pump was ordered.
- 8) PSE&G installed a new gas line in Koelle Blvd. for the dual fuel emergency generator.
- 9) The Secondary Sludge pump transducer was reinstalled. The manufacturer found no problem with the unit. They thing a voltage spike caused the problem. A D.C. power unit will be installed to attempt to correct this problem.
- 10) New Benshaw V.F.D.'s were installed for the interim bypass pumps.
- 11) Plant water piping located south of the Secondary Clarifiers failed. Persistent Construction has been contacted to repair the pipe. We are awaiting the new arrival of new hydrants for the system.
- 12) The South Grit Collector chain is in need of replacement. New chain and parts have been ordered. The center channel chain is also scheduled for replacement.

#### PUMP STATION # 1 Village Place

- 1) The estimated average daily flow was 1.14mgd.
- 2) All pumps cleaned and maintained on a regular basis.
- 3) Routine maintenance and grounds keeping were performed.

#### PUMP STATION # 2 Paterson Plank Road and Turnpike Exit

- 1) The estimated average daily flow was 67,263 g.p.d..
- 2) Routine maintenance and grounds keeping were performed

#### PUMP STATION # 3 Henry Street

- 1) The estimated average daily flow was 73,623g.p.d.
- 2) Routine maintenance and grounds keeping were performed.

#### PUMP STATION # 4 New County Road and Seaview Drive

- 1) Routine maintenance was performed.
- 2) A bracket, holding the pump rails failed. Rapid Pump and Meter was awarded the job to repair the pump rails located in the wet well. They are waiting to begin the repair.

#### PUMP STATION # 5 Wilroy – Secaucus Road

1) This station is not in service. Grounds keeping was performed.

#### PUMP STATION # 6 Castle Road

1) Routine Maintenance and grounds keeping were performed.

2) The estimated average flow was 17,623 g.p.d.

PUMP STATION #7 - Exchange Junction

1) Routine maintenance was performed.

COLLECTION SYSTEM:

1) The Authority assisted the D.P.W. cleaning various catch basins throughout the town for the month.
